2. Interested parties are requested to attend the open auction on the given date and time on the following terms and conditions:-

- I. That 50% amount of the accepted bid will have to be deposited by the successful bidder at the spot to confirm the sale price, failing which the bid will be cancelled. The other 50% will have to be deposited within 03 days from the date of auction, otherwise, the advance payment (First 50%) will be forfeited in the Government interest.
- II. That the Vehicle / Motor Cycle can be inspected during office hours before the auction date.
- III. That the interested parties will have to deposit their Computerized National Identity Cards and Rs.25,000/- for each Vehicle & Rs,3000/- for each Motor Cycle through Postal Draft from any GPO or Bank Draft as seed money before participation in the auction procedure. The participation in the bidding will be restricted to fulfillment of the pre-requirements. The seed money will be returned back to the unsuccessful parties on the spot or adjusted for the successful bidders. Highest bid will be accepted. Transportation of the sold Vehicle / Motor Cycles will be the responsibility of the bidders.

- IV. That the Vehicle / Motor Cycle will be delivered to the successful bidders after full and final payment.
- V. The successful bidder will be responsible for new registration of the vehicle at his own cost. The successful bidder will also furnish on undertaking that he / she will never use Government Registration No. of Vehicle / Motor Cycle after taking possession of the same through bidding.
- VI. That the competent authority reserves the right to accept or reject the whole auction or a part thereof as per PPRA Rules.
